Crosslake

Located on the shores of Cross Lake and the Whitefish Chain, the Northwoods village of Crosslake is a recreational paradise. Travel down County Road 66 and into the city's picturesque Town Square and you'll find unique shops, great golfing, wonderful restaurants and an amazing campground teaming with tourists throughout the year. A biking/walking trail runs through the community and links to trails along the Paul Bunyan Scenic Byway.

Stars & Stripes Days (non-juried event):

- * Complete application
- * Check must accompany application*
- * All artists must comply with Minnesota statutes by having an Operator Certificate of Compliance (ST-19) on file with the Brainerd Lakes Area Chamber of Commerce office. If the Chamber does not have one on file, please send the ST-19 with your application.

Bean Hole and Crosslake Days (juried events):

- * Complete application
- * Submit three images by mail or email. Label each photo clearly with the exhibitor's name and medium. Photos must be representative of the work exhibited. All work must be 100 percent original in design and final product. Preference will be given to exhibitors with original craftsmanship and consistency in the work and a command of the medium. No imports, commercial jewelry, kits, molded ceramics or manufactured items will be accepted.

Check must accompany application*

All artists must comply with Minnesota statutes by having an Operator Certificate of Compliance (ST-19) on file with the Brainerd Lakes Area Chamber of Commerce office. If the Chamber does not have one on file, please send the ST-19 with your application.

Bean Hole Days, Pequot Lakes Trailside Park

A salute to area farmers that began in 1938 continues today as an all-community celebration. Cast-iron kettles of beans, cooked overnight in the ground, are served for free to thousands of attendees. Join 40 plus craft vendors for this premiere summer festival.

Application and payment due by June 1, 2018. A late fee of \$25 will be applied to all applications received after this date.

Crosslake Days, County Rd 66 in Crosslake

This fun-filled event has been delighting festival-goers since 1986! Thousands descend on Crosslake to celebrate the arrival of fall with a chili cook-off, classic car and motorcycle show and over 75 craft vendors in the center of it all!

Application and payment due by August 31, 2018. A late fee of \$25 will be applied to all applications received after this date.

Important Event Information

Booths: All booth spaces are 10'x10'. Spaces are assigned by the event committees and no special requests will be accepted. Care will be taken not to place like vendors next to one another. All spaces are outside. Artists are responsible for providing tent, table and chairs and electrical source. Tents must be adaptable to grass or blacktop.

Cancellation/refund: Once the Chamber has received your application with payment it is expected you will attend. If you find it is impossible to do so, please notify the Chamber as soon as possible, as we want to offer your space to an exhibitor on our waiting list. Your application fee less a \$30 administrative fee will be refunded up to the deadline of June 1 for Stars and Stripes and Bean Hole Days and August 31 for Crosslake Days. If cancellation is made after these deadline dates, your application fee will be forfeited.

Set up/tear down: Artists attending Bean Hole Days may set up after 5:00 p.m. on Tuesday, July 10 or before 9:00 a.m. on the day of the event, Wednesday, July 11. Stars and Stripes and Crosslake Days require same day set-up.

Booths can be torn down after 4:00 p.m. on the day of the event. Please make sure all garbage around your site is picked up.

Sales tax: Artists are responsible for collecting and reporting Minnesota sales tax. You may register for a Sales Tax Permit by phone at 651-296-6181 or by going online at www.taxes.state.mn.us. All artists must comply with Minnesota statutes by having an Operator Certificate of Compliance (ST-19) on file with the Brainerd Lakes Area Chamber of Commerce office.
